### **INVITATION TO TENDER**

1. The Water Authority of Jordan –WAJ requests eligible local Contractors, registered with the Ministry of Public Works and Housing, of First Grade for water and sewerage works (single or in Joint Venture), to tender for the performance of the contract as detailed below. Eligible Contractors may win a maximum of 1 contracts of this project.
2. The water supply infrastructure in Greater Amman suffers from a high amount of Non-Revenue Water (NRW) in the tertiary network system of approximately 37%, mostly real losses (physical losses from leakage) but also apparent losses (nonphysical due to meter errors and unauthorised consumption). Therefore, WAJ has signed a loan agreement with the Government of Germany to fund a project for rehabilitation of the tertiary system and house connections in selected areas in Greater Amman.
3. Similar Works within the last 10 (ten) years:  
Supply and Installation of the Water Supply Network (Installation of Polyethylene pipes of high density, Fittings, Gate- and Air Valve, House connection) in Jordan; at least 1 contract with a minimum value of 2.0 Mio JOD for the single contract. Supply and Work Contracts to be proved by copies of contract agreements and Certificates of completion.
4. The eligible Tenderers shall have a clean record for the past 5 (five) years in terms of contract termination, liquidation of guarantees, and delay in works exceeding 30% duration of the contract period and must not be blacklisted by the GTD in the water sector. Upon request, the Tenderer shall submit documentary evidence to proof this requirement.
5. The tender documents, 1 hard copy and 1 soft copy, can be obtained from the Water Authority of Jordan –WAJ for a non-refundable fee of 300, 00 JOD by an authorised representative of the Tenderer. Tendering will start on **December 5<sup>th</sup> 2011 at 12:00 noon** time. Tender documents can be obtained until **December 19<sup>th</sup>, 2011, 12:00 noon** time.

7. Tenderers shall attempt to bid based on their financial and economic eligibility, experience, resource availability as well as quality of supplies offered according to the technical specifications.

9. The scope of work comprises the supply of materials as well as the installation for the rehabilitation of the tertiary distribution system and house connections in DZ19-Lot 1Batch 1 of the Water Supply of Greater Amman IV Project.

The works shall include, but not necessarily be limited to, the following elements:

- 21,600 m HDPE pipes with diameter from DN20 (ISO25) to DN25 (ISO32)(included in the house connections);
- 18,500 m HDPE pipes with diameter DN50 (ISO63);
- 34,000 m HDPE pipes with diameter DN100 (ISO125);
- 4,000 m HDPE pipes with diameter DN150 (ISO180);
- 300 m DI pipes with diameter DN200
- Replacement of approximate 2,700 house connections;

- Installation of 50 Service Valves;
- Installation of 50 Air Valves;
- Installation of 685 network node points inclusive 119 gate valves;

10. The performance time of the contract is **22 months**.: 660 Calendar Days
